LETTER FROM PRESIDENT/CEO



The Embassy's 2019-20 fiscal year was an interesting ride. We moved through half the year with a full schedule, meeting goals and serving northeast Indiana like any other year. We enthusiastically continued to fulfill our strategic plan by prioritizing regional collaborations, educational programming and Embassy Presents shows and events. Our continuous goal was to engage our audiences in diverse and creative ways through rich national and local arts experiences. And then, the unexpected happened to us all. And through that immense challenge, we found resilience.

The Embassy was very busy when the pandemic hit. With the limitations, cancellations and ongoing changes to the world as a result of COVID-19, the 2019-2020 season presented significant barriers to venues like ours. However, instead of saying "we can't," the team figured out how to say "this WILL be different, and we can."

We adjusted immediately and were able to reschedule most events to later dates. We developed best-practice health and safety protocols for staff, patrons, volunteers, vendors and artists. We shifted to streaming event options, reduced event capacity and created plans that were approved by the department of health so that we could still remain active in our community. And once there was an understanding that national tours would be suspended for some time, we refocused on local partnerships with area arts colleagues and organizations who could not host activities in their home venues. We implemented a racial equity statement to take an active role in creating change. And we launched our fundraising campaign, Raise the Curtain, to help offset revenues lost by the pandemic.

Now that the calendar is filling up more normally, we are quite hopeful and continue to rebook shows and continuously field inquiries about future events as the world settles back into a rhythm of activity and gathering. With the support of Embassy members, sponsors and donors we remain an arts and cultural hub for this region and for fans of all generations.

Thank you for your ongoing appreciation of the Embassy Theatre! Your support makes a tremendous difference especially in the difficult times. We look forward to seeing you very soon.

Embassy educational programs connect new generations with the theater, offering curriculum-based live arts experiences, insight into its history and understanding of how the Embassy serves and benefits the community.

.....

In 2019-20, educational arts and humanities programs served participants from 88 public schools, 22 home school groups, 12 parochial schools, 2 arts partners, 1 after-school program, 1 day camp and 1 head start program. More than 52% of students served are eligible to participate in the National School Lunch Program and 15% live in underserved rural communities surrounding Fort Wayne.



2019-2020 EDUCATIONAL PROGRAMMING



STUDY TRIPS: Four program modules make use of artifacts, historical documents, role-playing and sensory exploration to examine the rich history of the theater and connect students with the real-life effect of historic preservation. Two program modules have been developed as virtual lessons for classrooms, in partnership with 323 Media and Purdue University Fort Wayne's Center for Collaborative Media.



LEARN IT LIVE: This series offers curriculum-targeted arts performances and demonstrations serving large elementary- and middle-school audiences; the 2021-22 season will feature Full STEAM Ahead-When Science Goes Viral with Mr. C, Trekking Mexico, Black Violin, and Step Afrika.



SCORE!: An intensive three-week devised theatre workshop incorporates play-writing, drama, music and production, culminating in a full-scale production on the Embassy stage. Middle school-aged participants are recruited through school and local arts and community partners, and the program is open to kids of any ability. Scholarship funding and financial aid is available.



YOUNG PEOPLE'S CONCERTS and LINK-UP:

Co-presented with FW Philharmonic—this free program begins with classroom music-making, guided by curriculum developed by Carnegie Hall's Weill Music Institute—culminating in an interactive orchestral concert each spring.



HEROES of CONSCIENCE: Co-presented with FW Youtheatre—performances serve grade-school audiences with original biographical theatre that educates, entertains and captures the human experience.
